


# Executive Director FAMU Centers and Institutes Position Description



## The Opportunity

Florida Agricultural and Mechanical University (FAMU) is seeking a strategic, data driven, and financially savvy leader to serve as the Executive Director for FAMU Centers and Institutes.

The Executive Director for FAMU Centers and Institutes will provide strategic oversight, operational management, and performance evaluation for all research centers and institutes at Florida A&M University. This role ensures that each center and institute align with FAMU's mission, meets established return on investment (ROI) benchmarks, and complies with state and federal reporting requirements.

#### The Position

This position reports to the Provost and Vice President for Academic Affairs and works closely with all division vice presidents, academic deans, faculty, research staff, and external partners to ensure the long-term success of FAMU's center and institute enterprises.

The Executive Director will oversee center and institute leadership, coordinate strategic planning, review financial and operational reports, and provide data-driven recommendations to enhance research productivity and funding sustainability. A critical responsibility of this role is preparing and submitting reports for the Florida Board of Governors (BOG), demonstrating FAMU's research impact and alignment with state priorities.

#### **Key Responsibilities**

#### Strategic Oversight & Center/Institute Leadership Management

- Directly oversee all Center and Institute Directors, ensuring alignment with FAMU's research priorities and institutional mission.
- > Establish and monitor performance metrics, annual goals, and strategic priorities for each research entity.
- > Conduct quarterly reviews of center and institute operations, including financial health, research output, and workforce impact.
- > Ensure compliance with university, state, and federal research funding, expenditures, and reporting policies.

#### **Emerging Technologies and Resources**

- Demonstrate basic knowledge and understanding of emerging sciences and technologies rapidly being fostered by advanced technologies, including the new discipline of Research Computing and Data [RDI]
- Maintain knowledge of advance technologies (e.g., Artificial Intelligence, Quantum Information Process) and assess the impact on the landscape of international humanitarian law (IHL).
- > Utilize and actively promote national resources such as the National Artificial Intelligence Research Resources (NAIRR), and the National Data Platform (NDP).

#### Quarterly Reporting, ROI Analysis & Florida BOG Compliance

- Review and assess quarterly reports from each center and institute, funding alignment, acquisition, scholarly output, student involvement, and community impact.
- Develop and implement ROI metrics to measure the effectiveness and sustainability of each research entity.
- > Develop a strong understanding of Florida Board of Governors (BOG) regulations related to research centers and institutes.
- > Prepare and submit annual reports for the Florida Board of Governors (BOG), ensuring compliance with state funding requirements and performance expectations.
- Maintain and present data on research expenditures, grant funding, faculty contributions, and student engagement to internal and external stakeholders.

#### Financial Stewardship & Research Sustainability

- > Ensure budget accountability for each center and institute, optimizing financial resources for research productivity.
- > Identify grant opportunities, funding partnerships, and cost-saving strategies to enhance research sustainability.
- Review and approve operational budgets, external funding agreements, and financial projections for each research entity.
- > Collaborate with the university divisions to maximize federal, state, and private funding opportunities.

#### Stakeholder Engagement & Institutional Partnerships

> Serve as the primary liaison between FAMU Centers and Institutes and university leadership, state officials, federal agencies, and industry partners.

- > Facilitate collaboration between research entities and academic departments, external sponsors, and government organizations.
- Represent FAMU at conferences, policy discussions, and advisory meetings to advocate for institutional research priorities.

#### **Minimum Qualifications**

- Possession of a terminal degree (e.g., PhD, EdD, MD, JD, or equivalent) in a discipline offered by the university.
- Demonstrate qualifications and scholarly achievements appropriate for appointment to a tenuretrack faculty position in a discipline offered by the university.
- > Proven leadership experience (minimum 7-10 years) in research management, grants administration, and higher education executive roles.

#### **Preferred Qualifications**

- Basic knowledge, understanding, and promoter of experiential learning and new learning modalities fostered by cyber collaboration, innovation, sustainability, and resilience. (e.g., AI, Cybersecurity, Cyber policy, Ethics, etc.)
- > Strong financial acumen with experience overseeing research budgets, ROI assessments, and grant funding.
- > Demonstrated ability to analyze research impact data, prepare high-level reports, and present findings to university leaders and government agencies.
- > Experience managing faculty, researchers, and interdisciplinary teams in a research-intensive environment.
- > Excellent communication, policy development, and stakeholder engagement skills.
